WACE MEMBER ON THE MOVE!


Ronda Litzau, formerly with City Of Sammamish, has moved!

pleased to announce that WACE is in good financial condition.

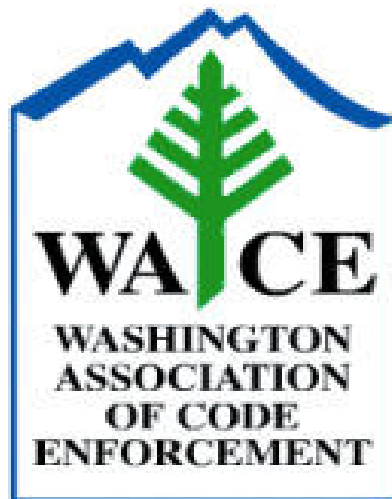
